5.1. Extinguishing media

Extinguishing media: Carbon dioxide. Dry chemical powder. Alcohol resistant foam. Suitable extinguishing media for the surrounding fire should be used.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Hydrogen fluoride (HF). Borane/boron oxides.
